Documentation Needed

Financial aid funds are awarded based upon availability of funds and established need. In order to establish this need, the Board of Directors requires the following documents from the applicant:

- **Completed** Financial Aid Application
- Copy of income tax declaration for Brazil and/or foreign, as applicable, for the last year filed. If both parents are working, their joint or individual tax declarations must be included. If only one parent is working, a statement that the other does not earn any income must be included.
- Copy of the last three salary statements (holerites) for both parents.
- Copy of your most recent bank statements for all of your bank accounts in the last three months for both parents.

Criteria for Awarding Financial Aid

Because financial aid funds are limited, certain criteria will be followed in awarding financial aid:

1. Financial need: based on parents' income, expenses and assets.
2. Tuition bills and payments **must be up-to-date** with the school's finance office to receive month by month financial aid. The benefit of financial aid depends upon paying the "Boletos" on the due date, i.e. If the monthly payments falls after the due date the student will lose the benefit.
3. Academic standing of the student. **Financial aid may be discontinued if a child displays serious misbehavior or academic problems.** The student must maintain an average of C- or better to maintain the scholarship.
4. The spiritual life of the student will be considered.
5. Continuing students will be given preference over new students. Students in higher grades will be given preference.
6. Aid will be granted only to students who have spent at least two semesters at PACA.
7. Financial aid shall only be granted to children in grades 1st - 12th.
8. Financial aid is granted on a year to year basis. A new application must be made each year.

Requests for financial aid must be submitted in printed form by APRIL 30, 2026 for aid that is to begin in July. A personal interview may be required. Applications will be held in the strictest confidence.
